CREDENTIALS – ACCORDING TO BYLAWS

A Credentials Report is required by each chapter, regardless if any members are attending.

Article VII – Meetings

Section 2. The voting members of the General Court shall be the Officers of the National Society, the Honorary National Presidents, the President and Vice President of each Chapter, and the delegates, or their alternates, of each Chapter who paid membership is in accordance with these bylaws.

Section 3. Each Chapter shall be entitled to elect one delegate for each 25 members, or fraction thereof, who dues have been received by the National Treasurer on or before December 31st. Delegates and alternates to General Court shall be elected on or before March 15th. Representation at any meeting of the National Society during the year beginning January 1st shall be based on the number of members whose dues have been received by the National Treasurer on or before December 31st. Any member whose dues have not been received by that date shall not be eligible to represent a chapter.

Section 4. Each chapter shall be entitled to elect two alternates for each voting chapter officer or delegate.
